43	➤ Personnel	5 Points
44	➤ Experience	15 Points
45	➤ Understanding Scope of Work	10 Points
46	➤ Financial Capability	10 Points
47	➤ Geographic Location	10 Points
48	➤ Schedule	25 Points
49	➤ Price	25 Points*
50	➤ TOTAL POINTS	100 Points

51 \*15 points of the 25 points would be awarded to the proposer submitting the lowest cost proposal,  
52 and all other proposals would receive a percentage of this amount, based upon the difference between the  
53 proposer's bid and the low proposer. The other 10 points of the 25 points would be for the reasonable  
54 debt of the unit prices and balance of the proposer.

56 On a MOTION by Mr. Harvey, SECONDED by Mr. Walker, WITH ALL IN FAVOR, the Board  
57 approved the Evaluation Criteria, and authorization to issue an RFP using the adopted criteria as  
58 recommended by District Counsel, for the Avalon Groves Community Development District.
